



REGISTRATION & TUITION INFORMATION



1. A \$175 registration fee is required per family. This fee is non-refundable and does not apply to tuition or school fees.
2. **All families must enroll in FACTS Tuition Payment Plan.** Families will be able to pay in full or utilize payment option plans. Families will have the option of a ten-month payment plan beginning on July 1st or 15th and ending on April 1st or 15th. Families may also choose to pay quarterly or semi-annually. Families will have the opportunity to choose a 1st of the month OR 15th of the month payment due date. **There is a fee of \$46 for this service if paid monthly; \$46, quarterly; and \$20, semi-annually. These fees are paid directly to the company. If tuition is paid in full, no fee will be assessed. Non-sufficient funds and late fees will be assessed through FACTS.** (All fees are subject to change.)
3. Each family seeking a parish subsidy (financial aid) will make an application through FACTS financial aid online. Each parish will determine the amount of subsidy based upon the information obtained from FACTS and the monies each parish has available for this purpose. **A non-refundable fee of \$30 paid directly to FACTS will be assessed.**

5. The Catholic Education Foundation (CEF) is again accepting applications for needs-based elementary school tuition grants for the 2023-2024 school year. Grant awards range from \$250 to \$1,000 per student and can be used at any Catholic elementary school within the Archdiocese. For more details and to apply visit: www.catholicbestchoice.org.
6. Families may apply for an Angel Grant provided by St. Gabriel Consolidated School. The grant amounts vary. Please see attached application.
7. Any student who attends any part of the school trimester and withdraws will be charged for the trimester in which the withdrawal takes place.
8. A list of registered students by parish will be sent to each parish in March to confirm family eligibility for parish status. Additions and deletions to this list will be sent by the school to the parish office as they occur. Parishes will notify the school if movement occurs from the parish.
9. FACTS will keep the school aware of late or non-payment of tuition. Circumstances may arise within a family where tuition payments are delayed. **Families need to communicate these circumstances to the business manager at (513) 771-5220 ext. 3 prior to payment due date.** Late payment of tuition may result in termination of enrollment.
